**Introduction**

These motions are submitted to correct errors in prior motion filings, the striking of

two documents which were attempts to correct ECF 76-4 which had incorrect 'title' information as well as errors in the proposed Second Amended Complaint (ECF 76-1)

### **Strike ECF 77 and ECF 81**

The court is asked to direct the clerk strike documents ECF 77 and ECF 81 which were intended to correct inadvertent mistakes in the 'title' of ECF 76-4. I apologize for the errors and any confusion which resulted, but it appears that my normal habitual procedure for verifying the accuracy in documents had a glitch for certain classes of errors delaying detection as well as correction. I hope to correct my verification process so that similar glitches are less common in the future. ECF 82 is the corrected document. Defendants do not oppose the striking of these documents.

### **Notice of Corrected Filings (ECF 76-1)**

We are seeking to replace the previously proposed complaint (ECF 76-1) to cite the corrected document ECF 82 instead of the incorrect ECF 76-4 as well as correct a typographical error to cite [26 USC § 6331](#) instead of 8 USC § 6331 (which does not exist). The basis for these corrections is that the proposed complaint was verified which creates a moral, ethical, and, possibly, legal obligation to notify parties of such errors and attempt to correct the errors to limit the misunderstanding and confusion which would result from the inaccurate statements.

The Defendants stated:

You may reflect that Defendants oppose amending Plaintiff's previously proposed complaint. Defendants will not oppose a notice of correct to note the two above-referenced errors.

I interpret this to mean that the Defendants are not opposed to the correction of the errors cited above but remain opposed to the proposed 2<sup>nd</sup> Amended Complaint (whether corrected or not).

The court is asked to decide the current motion to amend the complaint (ECF 76) based on a proposed amended complaint of ECF 84-1 which incorporates these corrections rather than the previous ECF 76-1.
